

## **OPT CHECKLIST:**

Deadline for OPT (Optional Practical Training) – Apply 90 days before the Program End Date or within 60 days after.

## **Types of OPT:**

Post Completion C.3.B. – you can apply for post-completion OPT after completing your studies. If you are approved for post-completion OPT you can work full time, or part time (20 hours a week). If you participated in pre-completion OPT, USCIS will deduct that amount of time from your post completion OPT period.

Pre Completion C.3.A You may participate in pre-completion OPT after you have been enrolled on a full time basis for a full academic year at a college or any other higher education institution, certified by ICE (Immigration and Customs Enforcement, SEVP (Student Exchange Visitor Program). (www.USCIS.gov/opt)

Required documents to complete OPT application:

## Completed Form I-765: <a href="https://www.uscis.gov/sites/default/files/document/forms/i-765.pdf">https://www.uscis.gov/sites/default/files/document/forms/i-765.pdf</a> Two passport photos (Photos must take the following format: color photos with a white background. Photos should be unmounted, printed on thin paper, glossy and unretouched. The photos should be passport-style and recently taken (within the last month). Copy of a Passport ID page, Visa (Passport must be valid for 6 months or more) Print out of Form I-94; <a href="https://i94.cbp.dhs.gov/I94/#/home">https://i94.cbp.dhs.gov/I94/#/home</a> Form I-20 (Student) Copies; you need copies of all previous I-20, especially ones with all OPT or CPT requests. Copy of New I20 issued with OPT request (You will then need to mail or file your OPT packet within 30 days of OPT I-20 being produced.
